9. Distribution of Net Value Added (NVA)

Table-10 and the following Chart show the Distribution of Net Value Added at 2 Digit level of NIC code with illustration of industries in the years 2004-05 & 2005-06.

The Industry group (NIC code 30) Manufacturing Office, Accounting and Computing had the largest share in the Net Value Added during the reporting year 2005-06. It was Rs.155033 lakhs (50.84% of total) as against the industry group (NIC code 24) Manufacturing Chemical & Chemical Products had recorded the largest share in 2004-05 and it was Rs.41451 lakhs (27.31% in total). The highest increase in Net Value Added in terms of percentage was 481.54% in industry group (NIC code 30) Manufacturing Office, Accounting and Computing Machinery in 2005-06 over the previous year 2004-05.

The Industry group (NIC code 24) Manufacturing Chemicals & Chemical products had the second largest share in the Net Value Added in 2005-06 whereas the industry group (NIC code 30) Manufacturing office, Accounting and Computing Machinery had occupied the second largest share in 2004-05. It was of the order of Rs. 45661 lakhs (14.97% in total) and Rs.26659 lakhs (17.56% in total) respectively.

The Industry groups (NIC code 15, 21, 25, 26, 28, 29, 31, 32 33, 34, 35 36 and 40) namely Manufacturing Food Products and Beverages Manufacturing Paper and Paper products, Manufacturing Rubber and Plastic Products, Manufacturing other Non-Metallic Mineral Products, Manufacturing Fabricated Metal Products, except Machinery and equipment, Manufacturing Machinery and Equipment, n.e.c. Manufacturing Electrical Machinery and Apparatus, Manufacturing Radio, T. V. & Communication Products & Apparatus, Manufacturing Medical instruments & Clocks & Watches, Manufacturing Motor vehicles, Trailers, Manufacturing other Transport Equipment, Manufacturing Furniture and Other products have shown an increasing trend in Net Value Added in 2005-06 over 2004-05.

The Industry groups (NIC code, 17, 19, 20, 22 and 27) Manufacturing Textiles, Manufacturing Leather Products, Manufacture of Wood and of products of wood and cork, except furniture Manufacturing articles of straw and plaiting materials, Printing, and Publishing & Reproduction of Recorded Media and Manufacturing Basic Metals have shown a downward movement in Gross Value Added in 2005-06 over 2004-05.

Overall, an increase of 100.93% was observed in Net Value Added in 2005-06 (Rs.304956 lakhs) over 2004-05 (Rs.151776 lakhs).
