NOTIFICATION

The Directorate of Economics and Statistics, Puducherry proposes to engage one number of Consultant from among the retired Deputy Directors of Economics and Statistics to undertake the following tasks, which requires expertise.

- (i) Price Statistics (New Series)
- (ii) Collection of Price for Local Govt. Departments
- (iii) Improvement of Crop Statistics (ICS)
- (iv) Timely Reporting Scheme (TRS)
- (v) Preparation of Season and Crop Report
- (vi) Agriculture Census and Input Survey
- (vi) Agriculture Statistics Compilation
- (vi) Preparation of Monthly Price Bulletin
- (vii) Any other subject as required by Directorate

2. He/she will be on contract basis for a period of six months or completion the tasks whichever is earlier. He/she will be engaged on full time basis with a fixed monthly remuneration, arrived at by deducting the basic pension from the pay drawn at the time of retirement.

3. The age of the consultant to be engaged shall not beyond 65 years as on 30.09.2025.

4. The willing and eligible retired Deputy Directors of Economics and Statistics who fulfils the eligibility conditions may apply in the prescribed format (Annexure I), on or before 30.09.2025.

5. The selection process and other terms and conditions of the engagement shall be as per the guidelines stipulated in the I.D.Note/Memorandum No. 463241/FD/F3/2014 dated 11.09.2014 and subsequent amendment dated 01.12.2022, of the Finance Department, Puducherry.

ANNEXURE**TERMS AND CONDITIONS FOR ENGAGEMENT OF RETIRED DEPUTY
DIRECTOR AS CONSULTANT**

(a) The maximum age-limit for the Consultants will be 65 years. No retired Government Servant should be engaged as a Consultant beyond the age of 65 years.

(b) The initial engagement shall be for a period of six months and subsequent extension if any, shall be decided on case to case basis with the recommendation of the Consultancy Evaluation Committee.

(c) The appointment shall be of a temporary (non-official) nature against specific job and the appointment may be cancelled at any time by this Directorate without assigning any reason.

(d) The consultant, so engaged, shall not be permitted to take up any other assignment during the period of consultancy.

(e) A fixed monthly amount shall be admissible, arrived at by deducting the basic pension from the pay drawn at the time of retirement. The amount of remuneration so fixed shall remain unchanged for the term of the contract. There will be no annual increment / percentage increase during the contract period.

(f) The Consultant, so engaged, shall not be entitled to any allowance such as Dearness Allowance, Residential, Telephone, Transport facility, Residential Accommodation, Personal Staff, Medical Reimbursement, Insurance etc. However, He/She will be entitled for Travelling Allowance on official tour at the rates applicable to a Government Officer holding equivalent post on regular basis. His/Her engagement as Consultant shall not be considered as a case of re-employment.

(g) The Consultant, so engaged, shall be eligible for 12 days leave in a calendar year on pro rata basis. Therefore, the consultant shall not draw any remuneration in case of his/her absence beyond 12 days in a year (calculated on a pro rata basis). His/Her unavailed leave in a calendar year cannot be carried forward to next year as well as not entitled for encashment of unavailed leave. The Department would be free to terminate the services in case of absence of a Consultant by more than 15 days beyond the entitled leave in a calendar year.
